Membership Categories and Terms & Conditions

The Foundation shall consist of the following categories of members:

1. Annual Member (Ordinary)

Any individual who:

- Pays an admission fee of **Rs. 5,501/-**.
- Pays an annual subscription of **Rs. 3,500/-**.
- Possesses their own weapon(s) for practice.

Such individuals shall be admitted as Annual (Ordinary) Members of the Foundation.

An Annual Member shall not be entitled to use the facilities of the Foundation unless the annual subscription for the current year has been paid.

2. Junior Annual Member

Any individual who:

- Is **below 18 years of age as on 31st December** of the relevant year.
- Is studying in a recognized school, college, or educational institution.
- Possesses their own weapon(s) for practice.
- Pays an admission fee of **Rs. 3,001/-**.
- Pays an annual subscription of **Rs. 2,500/-**.

When a Junior Member attains the age of 18 years, they shall be required to obtain an Annual (Ordinary) Membership by paying the applicable admission fee and annual subscription prescribed for Annual Members.

General Conditions:

- The admission fee and annual subscription are **non-refundable** under any circumstances, including cancellation or termination of membership.
- Annual Members shall pay their annual subscription during the **first week of January** each year.
- If an Annual Member fails to pay the annual subscription for **two consecutive years**, the membership shall stand automatically cancelled without any prior notice.

Important Instructions:

1. Every applicant shall submit:
 - Three passport-size photographs; and
 - Proof of residence (Aadhar copy) along with the membership application.
2. Junior Members shall submit proof of age and valid Bonafide Certificate issued by their school, college, or educational institution.
3. Senior Members shall submit a copy of Arms Licence for relevant weapons as applicable (The original document shall be produced for verification.)
4. Members shall register their names in the attendance register every time they visit the shooting range.
5. Members shall pay the prescribed charges for targets, pellets, ammunition, and lane usage.
6. Every new member must successfully complete the mandatory Safety Course before using the range facilities.
7. Every shooter shall submit a duly signed Undertaking-cum-Indemnity Form.
8. Members shall maintain strict discipline and follow all safety rules while using the shooting range.
9. Annual Members shall not be issued any certificate required by the Police or any other authority, except certificates relating to competitions, as approved by the Organizing Committee.
10. The Managing Committee reserves the absolute right to:
 - Accept / Reject / Suspend / Cancel any membership; and
 - Disqualify any member for indiscipline, misconduct, misbehavior, or any act considered prejudicial to the interests of the Foundation.
